Conditions for Membership in the IIABC are as follows:

Company Membership:

1. A company, corporation or partnership residing in B.C. and actively engaged in the provision of goods and/ or services to the irrigation industry of B.C. as a manufacturer, distributor, dealer or contractor shall be eligible to become a company member.
2. A company, corporation or partnership shall be eligible to become a company member.
3. Uphold the Constitution, By-laws and Objectives of IIABC.
4. A new member of the Association must be sponsored by two members in good standing and accepted by the Board of Directors.

Individual Membership*:

1. An individual working for a company, corporation, partnership or agency, residing in British Columbia who is not directly involved in the supply of goods and/ or services to the irrigation industry, (*ie. Parks employee, School Board maintenance employee, Government agency employee etc.*) with an active interest in the irrigation industry of B.C. shall be eligible to become an individual member.
2. An individual shall have one vote.
3. Uphold the Constitution, By-laws and Objectives of IIABC.
4. A new member of the Association must be sponsored by two members in good standing and accepted by the Board of Directors.

Associate Membership:

1. An individual, company, corporation or partnership located outside the province of British Columbia that is interested in irrigation and pledges to uphold the Objectives, Constitution and By-Laws of the Irrigation Industry Association of B.C. may become an Associate Member.
